

**NOTICE INVITING TENDER**

The Superintendent Odisha State Archaeology invites sealed tender from intending Suppliers / Authorised quarry holder / Contractors / Firms for supply of good quality **Sand Stone, Laterite Stone, Khandolite Stone** for use in conservation work of Temple / Monuments Historical Buildings. The intended supplier must possess valid Tin No & PAN No & submit photo copies of the Registration, experience and other related certificate like Income tax & Sales tax clearance along with tender schedules .The detail of the terms and condition of the tender is available in departmental website i.e. [www.odishaculture.gov.in](http://www.odishaculture.gov.in) which can be downloaded and should be submitted by speed post /courier/ by hand during any working days from the date of publication advertisement up to 3.30 P.M. 30.08.2016. The bid will be opened on the same day at 4.30 P.M. on 30.08.2016. . **The Technical bid and financial bid should be submitted separately up to specified time and date as stated above. The sealed cover should be super scribed with the name of work "Tender for supply of good quality Sand Stone, Laterite Stone, Khandolite Stone" & date of opening of tender.** The bid must accompany Rs.500/- towards cost of tender paper. Under no circumstances the bid will be accepted after the schedule date and time i.e. 30.08.2016, 3.30 P.M.

## TERMS AND CONDITION

1. The tender document must accompany Rs.500/- towards the cost of Tender paper. The amount to be paid in shape of demand draft in favour of Superintendent Odisha State Archaeology, payable at Bhubaneswar.
2. Correct / relevant information / data have to be furnished by the vendors.
3. The sealed envelope must be superscribed on the top of the envelope "Application for supply of good quality Sand stone/ laterite stone/ khandolite stone.
4. The supplier must furnish the following documents
  - 1) CST/VAT/TIN NO
  - 2) Trade license
  - 3) Income Tax permanent Account No.
  - 4) Audited balance sheet of profit & loss Account for the last 3 year if any
  - 5) Annual turnover Certificate for the last 3 year duly certified by C.A firm, if any
5. List of materials to be supplied:-
  - (1) Laterite Stone
  - (2) Sand Stone
  - (3) Khandolite Stone
6. Stone to be supplied must be suitable for conservation work of Temples/Monuments/ Historical Buildings.
7. The rate should be inclusive of all taxes including transportation charges, loading, unloading, Royalty, Vat etc. The supplier must quote the rate for supply Dist wise.
8. The successful tenderer will be required to supply the materials within 10days from the receipt of the work order.
9. The suppliers are also required to supply the material to any conservation site/ historical building/ Temples all over Odisha/
10. The approximate value of procurement of stones will be Rs.50,00,000/-(Fifty Lakhs only) approximately.
11. The Suppliers are to deposit 1% EMD of the procurement cost i.e Rs .50,000/-(Fifty Thousand only) with the tender in shape of Demand Draft of any Nationalised Bank to be obtained in favour of Superintendent Odisha State Archaeology which will be refunded after successful completion of the supply.
12. The EMD of the unsuccessful bidder will be refunded after completion of the tender process.
13. In case of non supply of materials within 10 days of receipt of work order, the EMD will be forfeited /the supplier will be black listed.
14. In case the material is not as per specification, the same shall be replaced by the Contractors/ Firm/ Supplier.
15. No claim whatsoever on account of fluctuation in prices will be entertained.
16. The competent authority reserves the right to accept or reject any or all the tender without assigning any reason thereof.
17. Sales tax or any other tax shall be payable by the Supplier/ Contractors /Firm and the Govt. will not entertain any claim whatsoever in this respect.
18. Any dispute relating to the tender & supply will be settled in the competent court of Bhubaneswar Jurisdiction only.
